Final balances must be paid with certified funds (payable to Greater Detroit Auto Auction ) this includes Cashiers Check, Money Orders, Bank Wire, Huntington Bank

Direct Cash Deposit, or Debit Card ( Supplemental 3% fee assessed on Non Cash Based payments )

**NO CASH, Personal Checks or Credit Cards are accepted for final payment.**

Any Vehicle NOT paid in full or placed in GDAA Layaway within 2 business days will be subject to forfeiture of any deposit and/or payment. GDAA Lay-away program is available to everyone. Please inquire at front office regarding this program. Late pay arrangements are available for a maximum of 1 business day pending seller approval and will incur a \$100 per day late fee.

**ADDITIONAL FEES :** GDAA Buyers Fee applies to all purchases. Check out Terms Tab on Auction Lots Page for details. State of Michigan fees are collected by GDAA which include 6% State Tax, \$15 Title Fee, and New Plate Fee/ Plate Transfer Fee. Document fee of \$75 will be added to all transactions. Non-Michigan customers will be charged a \$35 " In-transit " Fee. Title and Sales tax will differ depending on State of residency. Non – Michigan customers who lose their title that is issued to them and require GDAA to apply or assist in application for a new title will be assessed a \$ 200 lost title fee.

**LICENSE PLATES:** The State of Michigan requires Certificate of Insurance for all new license plates. The license plate fee includes the Temporary Tag. License plates can be transferred to new purchase if registration is in the buyers name, plate is not expired and the metal plate is present at time of final payment.

**STORAGE:** Any vehicles left on GDAA's lot after business days after final payment, will be charged \$15 per day storage.
